### Why have I been given this card?

This card contains important safety information that you should consider before starting treatment with voriconazole and for the period of the treatment:

### What should I do with this card?

- Always carry this card with you, for example, in your wallet or purse.
- Show this card to any doctor or health care professional who treats you.
- If you do not understand this information, ask your doctor for an explanation.

# What precautions should I take while taking voriconazole?

During treatment with voriconazole, you should avoid intense and prolonged exposure to direct sunlight. It is important to cover areas of skin exposed to the sun and to use plenty of sunscreen with a high sun protection factor (SPF), as your skin may have an increased sensitivity to the sun's ultraviolet rays.

In patients treated with this drug there is a small chance that skin cancer will develop over time.

# What should I do if I have a skin reaction?

You should contact your doctor if you have:

sunburn or an intense skin reaction after exposure to light or sunshine.

Do not forget to go to all your check-ups. Your doctor may feel it necessary to do blood tests and skin evaluations at these check-ups. Have a list of all the medicines you are taking and the medical conditions you have ready at each visit to a health care professional.
