#### 18. Details:

The company got multiple complaints from customers that ordered the product from the webpage <a href="www.ciclopoli.net">www.ciclopoli.net</a>. A complaint sample was analysed. Multiple falsification characteristics were noticed, for example:

- API Ciclopirox is not present.
- Lacquer is not water soluble (original lacquer is water soluble).
- Variable data is missing both on box and bottle.
- As leaflet the German Fachinformation (summary of product characteristics) is in the box instead of the regular patient information.
- Former packaging artworks are used showing the company logo "Taurus Pharma" that is not used anymore.
- Further discrepancies were observed on the bottle label as well in shape of the cap and the bottle.

The webpage <a href="www.ciclopoli.net">www.ciclopoli.net</a> seems to belong to the company 'Brand solutions Ltd.' and/or 'Brand solutions Trading', Bld. Aleksandar Pushkin 38, Office 6, Pavlovo 1618 Sofia, Bulgaria. Both Polichem S.A. and Almirall Hermal did not authorise any use of product information on the webpage. For 'brand solutions Trading' the address kv. BorovoBlk. 12, Entrance: B, Apt: 22, Sofia 1000, Bulgaria and the warehouse in Srebrostryi Industrial Area, Sofia, Bulgaria is also reported.

Since variable data is missing on the falsified product and distribution is apparently outside the legal supply chain, a recall on pharmacy and wholesaler level is not reasonable.
