18. Details:

On Tuesday, 02.05.2023, and Thursday, 03.05.2023, the Government of Upper Bavaria (Munich) received a request about the above mentioned 4 products by German customs office. It was reported that in the past, Sildenafil has already been found in a product with a comparable name, but different carton. There was also an initial suspicion based on the advertising on the internet. All products were sent from Turkey to Germany; the product Jaguar Power Honey identifies the manufacturer / distributor Shiny Face Central Trading in Dubai.

The products Bitkisel Karışımlı Macun Gold Q7, Bitkisel Karışımlı Macun Epimedyumlu Ginsengli (eniola Özel Üretim) and Bitkisel Karışımlı Macun Herbal Mixed Paste consist of one carton with a glass screw-top jar and a content with ca. 240 g. The products Jaguar Power Honey contains 12 sachets of 12,7 g in a carton. The appearance of the products is shown in the attached pictures.

The products were sent to Bayerisches Landesamt für Gesundheit und Lebensmittelsicherheit (OMCL) for further analysis in our responsibility. Today, it could be confirmed that all the products contain the API Sildenafil with the following concentrations (analysis report for intraagency use attached)

Already with a few grams of the samples, an amount of sildenafil is absorbed that corresponds to the lowest dose of the finished drug product Viagra.

Therefore, all products are classified as a medicinal product. The API Sildenafil is not indicated as an ingredient.
