



Field Safety Notice - Supine 2 and Multistander 2

1. Products affected

The affected products were manufactured between 5th April 2022 and 14th November 2023.

2. Description of the identified issue

A small number of products have been identified in which the actuator extends and/or retracts beyond its intended range of operation. Repeated operation beyond the intended range places additional strain on the actuator which can cause it to fail. Failures have been identified in a small number of products which are apparent because the angle adjustment of the support surface ceases to work. No injuries have occurred in relation to any affected product, however it has been identified that if the actuator were to fail while the product is in use there are two possible outcomes:

- Pressure in the lifting arm is lost, which means the upper frame can be pulled up and down by hand. Whilst this is unlikely to cause injury, it may be unpleasant for the user.
- Because of the above, the product may be stuck in the vertical position and cannot be returned to a horizontal position for ease of transferring the user. This means the user would need to be removed from the product while in a standing position which may increase the manual handling risks to both the user and carers.

3. Actions taken by the manufacturer

- Investigations conducted with Linak (the supplier of this part) have shown that the issue has been caused by the actuators being supplied with the incorrect operation limits installed in the operating software.
- Testing of a Beta version of the proposed new firmware supplied by Linak have been successful.
- Jenx will arrange for the control box on all products manufactured within the affected time period to be updated and operate on the new firmware with the correct operation limits set. The actuator will also be replaced.

4. Actions to be taken by the user/user's representative

The product is safe to continue to use in most instances, however please incorporate the additional information provided in this FSN into your risk assessment to determine the suitability for individual users while awaiting the software update and new actuator. Please do not continue to press the handset buttons once the product is in a full vertical or horizontal position as this puts further strain on the actuator arm.
