

Medicinal cannabis-based products

The Malta Medicines Authority reviews submissions and issues recommendations for activities relating to cannabis for medicinal and research purposes which go through approval processes in line with the relevant legislation, including the Drug Dependence (Treatment not Imprisonment) Act, Cap 537 of the Laws of Malta, and the Production of Cannabis for Medicinal and Research Purposes Act, Cap 578 of the Laws of Malta. Production, importation, wholesale distribution, prescribing and dispensing of medicinal cannabis-based products are subject to the relevant procedures, including licenses, approvals and permits, issued by the Superintendence of Public Health.

All stakeholders involved in the supply chain making medicinal cannabis-based products accessible to patients shall collaborate to ensure traceability and reconciliation practices are maintained throughout; this includes keeping records of the serial numbers of unit product packs up to the dispensing stage (including at producer, importer, distributor and pharmacy level).
